Course Overview

Introduction

Want a rewarding career working with children and prefer to learn on-the-job?

This traineeship will provide you with the skills and knowledge to gain entry-level employment in the early childhood education and care sector.

You will gain practical on-the-job knowledge and skills you need to support the implementation of a learning framework, and support children's wellbeing, learning and development. This course equips you to work across a range of age groups by providing care for babies, toddlers and children.

You must be employed as a trainee for a minimum of 13 hours a week in a regulated early learning centre to complete this course.

This course also provides a pathway and meets the entry requirements to complete the Diploma of Early Childhood Education and Care.

What will I Learn?

During this traineeship, you will learn through a combination of on-the-job training, workplace assessments and online study.

You will learn how to implement an approved learning framework within the requirements of the Education and Care Services National Regulations and the National Quality Standards

You will develop practical skills and knowledge in:

- · caring for babies and children up to 12 years old
- · developing positive and respectful relationships with children
- · providing experiences to supports children's play and learning
- · responding to children and young people at risk
- · effective interaction with children
- · childhood development
- sustainable practices
- · effective interaction with children
- · work health and safety procedures

Pathways

Following the completion of this course, you may choose to continue study in the Diploma of Early Childhood Education and Care.

Completion of the Certificate III in Early Childhood Education and Care meets the entry requirements and provides credits for the <u>Diploma of Early Childhood Education and Care</u> at South West TAFE. The Diploma can be studied <u>on-campus</u> or as a <u>traineeship</u>.

Course Requirements

This section gives you an overview of entry requirements, course units and electives, skills recognition, and assessment criteria.

Entrance requirements & pre-requisites

You must be employed as a trainee with a registered employer in a regulated early learning centre, be at least 17 years of age, provide a current Working with Children Check and obtain a police check.

Course requirements

To be eligible for this qualification you must successfully complete 17 units: 15 core and 2 elective units.

To successfully meet the requirements for the First Aid (HLTAID012) unit you must be able to demonstrate the physical capabilities required to follow the DRSABCD principles, in line with ARC guidelines including:

- performing at least two minutes of uninterrupted single rescuer CPR (five cycles of both compressions and ventilations) on an adult resuscitation manikin placed on the floor
- performing at least two minutes of uninterrupted single rescuer CPR (five cycles of both compressions and ventilations) on an infant resuscitation manikin.

Assessment

This course involves accredited units. You will be required to complete assessment tasks to demonstrate your underpinning knowledge, skills and attributes to meet the course outcomes. A combination of written, oral and practical assessment strategies will be used in either a classroom, online or workplace environment.

Where units require demonstration of skills in a workplace environment, you will have the opportunity to do this either in your own workplace (where appropriate), through a practical placement, or by using one of the Institute's simulated workshops/classrooms. Detailed information about the types, conduct and dates of assessments will be provided in advance. You will also be provided with information about the opportunity for reassessment and appeal.

After applying

Once you have applied for your chosen course, you will receive a thank you email from South West TAFE with a few steps to help process your enrolment.

Complete a Pre-Training Review

You will receive an email to complete a Pre-Training Review online evaluation. This evaluation helps us tailor your training to suit your needs.

Create or provide a Unique Student Identifier (USI)

A USI is a nationally recognised reference number that provides an online record of your training qualifications gained in Australia.

Skills recognition

If you have experience or prior qualifications, you may be eligible to apply for <u>recognition of prior learning</u> and gain credits. You will be asked to provide any relevant Statement of Attainment to support identified credits.

Course Fees





Here's an outline of fees and costs associated with your course.

Your fees each year can be made up of 3 different elements. Everyone has different circumstances that can affect what you pay and how much you pay.:

- 1. Tuition fees charged as an hourly rate that varies from course to course. A large portion of the tuition is subsidised by the Victorian Government for eligible students.
- Resource and/or materials costs covers the cost of materials and other incidentals. This fee will vary according to the course being undertaken.
- 3. Booklist items such as textbooks, equipment and stationery recommended for your course

Tuition fees

There are 4 different rates of tuition fees. Only one will apply to you (depending on your eligibility and circumstances).

- Government Subsidised Fee you could be eligible for a government-subsidised rate under the Skills First funding depending on your age, educational history, and citizenship or residency status. If you are eligible, the government will contribute to the cost of your training.

- Government Subsidised Concession Fee If you are eligible for a Skills First government-subsidised place and hold a current healthcare
 or pension card, that you can provide at enrolment, you may be eligible for the concession rate. Note, the concession rate is not applicable to
 Diploma level courses.

How do I pay my fees?

Once we have processed your enrolment form, you will receive an email with your invoice.

You have three options when organising your payment:

- 1. Upfront payment can be made over the phone with EFTPOS
- Payment plan can be directly debited from your bank account, debited from your Centrelink payments or via a <u>VET Student Loan</u> (for diploma or advanced diploma courses only)
- 3. Paid by employer, school or job network agency if your fees are being paid by your employer, school or job network agency, you will need to complete an Authority to Invoice form.

Payments will need to be arranged within five (5) business days of receiving the email containing your invoice.

We also offer a range of scholarships each year which you may be eligible to apply for to assist with course fees.

How to apply for an apprenticeship or traineeship

There are five simple steps to apply for an apprenticeship or traineeship with us.

- 1. Find a job find a job as an apprentice or trainee through an Apprenticeship Centre or Group Training Company.
- 2. **Register** register with an Australian Apprenticeship Support Network (AASN) and nominate SWTAFE as your training provider (your employer will usually do this for you).
- Complete a pre-training review SWTAFE staff will contact you to organise your Pre-Training Review once your ASSN contract registration is complete.
- 4. Enrol complete the enrolment form provided to you and provide your identification.
- 5. **Sign** once you've completed your enrolment form and verified your identification you will receive your student declaration form to review and sign. You can sign this digitally via your smartphone, computer or tablet.
